

## Collateral Management Solution

Ever since the financial crisis in the year 2008, there has been a drastic change in the perception of collateral management process. Preventive measures implemented by authorities brought in regulatory changes mandating the use of collateral for all market participants and penalizing all defaulters.

These new regulations have changed the traditional methods of managing collateral in a number of different ways, such as, monetary values, increased complexity, operational risks, liquidity risks, legal risks and cost impact.

Aligning to these new regulations has become a key challenge for asset managers as they make constant effort to maintain compliance every day.

## **The Challenge**

#### Need for end-to-end process automation

As part of its core functions, Global British Investment Bank, like many other firms, was also impacted by increased margin activity, collateral demand and expected rise in margin calls by 5-10 folds. They were running manual checks to reconcile data and experiencing slowness in their processes. Process challenges also included error prone copy-pasting of email data into spreadsheets, compromised calculation accuracy due to complex calculation rules and risk of compliance defaults due to unstructured data.

Global British Investment Bank realized the need for high-level operational automation which could offer an efficient and accurate collateral process to reduce manual intervention and be better equipped for future changes. They envisioned an end-to-end system capable of connecting to their mailboxes and the exposure manager sending margin calls directly to their downstream system with minimal manual touchpoints.

## The Solution

#### Intellimation.ai's AI-powered cognitive application

Global British Investment Bank' needs aligned with Intellimation.ai's cognitive process automation application 'Vector' and its disruptive, radical features, which uses ML and NLP-based libraries to train on unique processes, with promised adeptness in automating business problems as well as competitive pricing.

Intellimation.ai integrated Vector across Global British Investment Bank' global mailboxes; equipped with functionalities to read manually curated client emails, extract margin calls, generate XML messages and send it to the exposure manager. Output produced thereof was leveraged to perform multiple financial analysis for numerous counterparties, reducing manual intervention and mitigating operational risks.



## Implementation

Intellimation.ai integrated Vector across Global British Investment Bank's global systems with an existing exposure to **2000+** counterparties and implemented the following functionalities for endto-end process automation:

#### **1. Trade Ingestion and Extraction Modules**

Vector was connected to all the email inboxes which received trade emails at Global British Investment Bank across the globe. Already exposed to **2000+ variations**, Vector was able to ingest all formats of email attachments including PDF, RTF, HTML, CSV, XLSX received in unstructured form. Vector extracted and standardized the relevant data from unstructured sources and sent it to Exposure Manager as an XML message.

This enabled Global British Investment Bank to access consolidated data from multiple sources. This process was integrated to run round the clock, globally and the output thus produced could be leveraged by Global British Investment Bank' asset managers to perform multiple financial analysis.

#### 2. NLP-based Data Standardization and Reconciliation

The extracted details, including margin call, interest rates, MTM, collateral held/posted, independent margin, trade date, currency were standardized leveraging Vector's extraction column fields which could be modified as per user requirements.

Intellimation.ai's NLP and ML driven, proprietary algorithms and data enrichment capabilities enabled automatic enhancement of extracted data from margin call emails which was fit for financial analysis and further processing. The standardized output was then synced with Global British Investment Bank' system and here the disputed/ mismatched messages were promptly flagged and disputes were timely resolved by re-runs, manual checks and amendments.

#### 3. Extended Messaging and Payments Support

Vector was integrated with the Exposure Manger to achieve STP which not only reduced manual email-based engagement but also enabled high quality interaction with teams including, providing significant details like sharing margin information, acknowledgement, reason of delay, waiting in the queue prompts and more.

Vector's multi-layered algorithms enabled Global British Investment Bank to easily derive accurate data as well as metrics and exchange them at an intra and inter-firm level along with generation of SWIFT payment instructions, with attached margin calls for its clients.
